Dealer /Drop shipper Agreement

I, _____ agree to the terms listed below:

- 1 Dealer /drop shipper agrees to provide customer services reasonably and satisfactorily to end users, including initial assembly of products, installation and instruction in the use of new products, and post-sales service. (PDI – Pre Delivery Inspection by a certified technician).
- 2 Dealer /drop shipper shall maintain an inventory of service parts of a size reasonable to Dealer's sales volume, which will permit Dealer to service FMS products.
- 3 Dealer agrees to provide a service department for repairs of FMS products.
- 4 Initial order has to reach 5 bikes. Dealer /drop shipper agrees that all sales from Family Motorsports, Inc. are final (no returns or exchanges).
- 5 Be a Confident and Responsible dealer, complete services and not prices. We require all of FMS dealers set retail prices as high as desired, but cannot be more than \$200.00 lower than the "Sale Prices" that are posted on www.family-motorsports.com
- 6 Dealer /drop shipper agrees that any and all damages are solely between the trucking company and Consignee. Family Motorsports, Inc. **is not** responsible for shipping damage once products leave our warehouse. Please read "TASKS UPON RECEIVING GOODS" for detail.
- 7 Dealer /drop shipper agrees that the end users will contact Dealer /drop shipper for warranty issues and not Family Motorsports. Warranty details and exclusions can be found on www.family-motorsports.com and are strictly between Dealer /drop shipper and Family Motorsports. Parts shall be shipped from Family Motorsports to Dealer /drop shipper directly.
- 8 Family Motorsports, Inc. will provide DEALER the Certificate of Origin (MSO) with each vehicle; Dealer shall sign on back of each MSO and transfer it to the end user.

I have read this agreement and acknowledge my responsibility as a Family Motorsports, Inc. franchised dealer. I agree to take responsibility and provide the best quality service to my customers.
